## <u>Invitation to comment on RSPO Recertification of PT. Sawit Mas Sejahtera – Pangkalan Panji Palm Oil</u> Mill in South Sumatera Province, Indonesia.

PT. Sawit Mas Sejahtera a subsidiary of Golden Agri Resources Ltd with RSPO Membership No. 1-0096-11-000-00, has appointed BSI to conduct RSPO Recertification for its palm oil mill and supply base. The recertification scope will be conducted in one (1) Palm Oil Mill, and one (1) estate. The certification unit is Pangkalan Panji Village, Banyuasin III District, Banyuasin Regency, South Sumatera Province, Indonesia

BSI plans to conduct Recertification of PT. Sawit Mas Sejahtera – Pangkalan Panji Palm Oil Mill and supply base from 22 – 24 September 2020. The assessment will be conducted based on the Indonesia National Interpretation of the RSPO P&C for the Production of Sustainable Palm Oil 2018 (INANI 2020). The assessment will cover legal, environment, economical, workers' health and safety, mill supply chain, social aspects, workers welfare, stakeholder engagement and continuous improvement as required by RSPO P&C.
