Invitation to comment on RSPO Recertification Assessment of Sime Darby Plantation Berhad - Strategic Operating Unit (SOU 7) Bukit Kerayong Palm Oil Mill and Supply Base, Kapar, Selangor, Malaysia

Sime Darby Plantation Berhad with RSPO Membership No: 1-0008-04-000-00 has appointed BSI to conduct RSPO Recertification Assessment of its Strategic Operating Unit (SOU 7) Bukit Kerayong Palm Oil Mill and supply base.
