This is to inform that United International Enterprise Palm Oil Mill under the Parent company United Plantations Berhad with RSPO membership number (1-0004-04-000-00) had appointed BSI Services Malaysia Sdn Bhd ("BSI Malaysia") to conduct the Recertification Audit located at Pantai Remis, Perak, Malaysia. The audit will be conducted from 30/05 to 03/06/2022 against the requirements of Malaysia National Interpretation 2019 of the RSPO P&C 2018

Founded on Danish and Malaysian Expertise and Resources, United Plantations Berhad (UP) from a modest beginning in 1906, has over the years grown in size and stature.
