This is to inform that Segaria Palm Oil Mill under the Parent company Boustead Plantations Berhad with RSPO membership number (1-0012-04-000-00) had appointed BSI Services Malaysia Sdn Bhd ("BSI Malaysia") to conduct the Recertification Audit located at Semporna, Sabah, Malaysia. The audit will be conducted from 20/02 to 23/02/2023 against the requirements of Malaysia National Interpretation 2019 of the RSPO P&C 2018. The supply chain model is Identity Preserved.


