<u>Public Notification: RSPO Recertification Audit of Mosa Mill, Kumbango Mill, Waraston Mill, Kapiura Mill, and Numundo Mill, New Britain Palm Oil Limited - West New Britain, Sime Darby Plantation Berhad (RSPO Membership: 1-0008-04-000-00)</u>

Dear Stakeholders,

This is to inform that Mosa Mill, Kumbango Mill, Waraston Mill, Kapiura Mill, and Numundo Mill under the Parent company Sime Darby Plantation Berhad with RSPO membership number (1-0008-04-000-00) had appointed BSI Services Malaysia Sdn Bhd ("BSI Malaysia") to conduct the Recertification Audit located at West New Britain, Papua New Guinea. The audit will be conducted from 07-12/08 & 14-18/08/2023 against the requirements of PNG & Solomon Islands National Interpretation 2019 of the RSPO P&C 2018. 
