

Achievement of certification measures the expertise of an individual in the Lean Six Sigma methodology, the tool set and the practical application using a range of soft tools as well as the technical Lean Six Sigma skills.

Once you have gained BSI Lean Six Sigma certification, you will receive a Certificate of Achievement. Subject to your permission we will publish your name on a searchable online database.

### What does it mean to be a certified Green or Black Belt?

Achieving a certified Green or Black Belt proves an individual has:

- 1. Completed a recognised curriculum of training
- 2. Passed a recognised Lean Six Sigma examination
- 3. Demonstrated their ability to execute Process Improvement projects or assessments

All in a way that:

- Places the voice of the customer at the heart of the delivery and always considers processes from a customer viewpoint
- Contributes in a positive and significant way to the bottom of the business
- Is clearly linked to the business's strategy and objectives
- Is structured both in content and timing of execution
- Addresses the critical deliverables of DMAIC
- Applies the right tools effectively

- Optimises the involvement of the project team through effective facilitation, team work, influence and leadership
- Plans and executes successful communication
- Maintains project documentation

In addition, Black Belts will demonstrate:

- Coaching and training of sponsors, process owners and team members, as appropriate
- Management of relevant change issues
- Successful completion of a cross-functional, complex improvement project

These competences deliver sustainable benefits and are delivered to the business at the right time, for the agreed cost and to the appropriate quality.

# How do I get certified?

The certification scheme is available to all Lean Six Sigma students, but we will require evidence of having attended appropriate training if not through BSI. This will usually be provided by submitting a copy of the course certificate. Students must satisfy themselves that their course curriculum covered the areas that will be assessed during the examination.

### STAGE 1

Sit a two hour open book examination in an invigilated environment.

### **STAGE 2**

Submit a project outline following discussion with your nominated BSI tutor – this often happens during training.

#### STAGE 3

Present your project for assessment by BSI.

### **STAGE 4**

Your project will be assessed by a BSI Master Black Belt who obtains confirmation from your line manager or sponsor that the project delivered the outcome presented. If there are any perceived gaps or requirements the BSI Master Black Belt will advise you at this stage and will accept a re-submission.

### STAGE 5

You make a formal presentation of your project to the BSI Master Black Belt at an agreed location and time.
