## What is NITTP?

New Industrialisation and Technology Training Programme (NITTP) is a funding scheme under the Innovation and Technology Fund that subsidises local companies on a 2:1 matching basis to train their staff in advanced technologies, especially those related to "New Industrialisation". Each company is subject to a funding ceiling of HK\$500,000 in each financial year at the course commencement date. Companies should contribute no less than one-third of the actual training cost.
