



# <u>Public Notification: RSPO Recertification Audit of Kayung Agro Lestari POM, PT. Kayung Agro Lestari, part of PT. Austindo Nusantara Jaya Agri (RSPO Membership: 1-0032-07-000-00)</u>

Dear Stakeholders.

This is to inform that PT. Kayung Agro Lestari – Kayung Agro Lestari POM, subsidiary of PT. Austindo Nusantara Jaya Agri, with RSPO membership number (1-0032-07-000-00) had appointed BSI Services Malaysia Sdn Bhd ("BSI Malaysia") to conduct the Recertification Audit located in Kalimantan Barat Province. The audit will be conducted from 5-9 August 2024 against the requirements of RSPO P&C 2018 – Indonesian National Interpretation 2020. The supply chain model is Mass Balance.

RSPO PO ID number of the PT. Kayung Agro Lestari – Kayung Agro Lestari POM is: RSPO\_PO1000006366.

Organization background: PT Austindo Nusantara Jaya Tbk. (ANJ) is a holding company engaging directly and through subsidiaries in the production and sale of crude palm oil, palm kernel, palm kernel oil and other sustainable food crops, and renewable energy. Our business comprises the integrated cultivation and harvesting of fresh fruit bunches from our oil palm plantations, milling them into crude palm oil, palm kernel and palm kernel oil and selling the oils. ANJ owns five oil palm producing plantations with mature and immature oil palms, served by an on-site processing mill as follow: PT Austindo Nusantara Jaya Agri (ANJA) with 9,988 hectares oil palm plantation in Binanga, North Sumatra; PT Austindo Nusantara Jaya Agri Siais (ANJAS) with 9,412 hectares oil palm plantation in Padang Sidempuan, North Sumatra; PT Sahabat Mewah dan Makmur (SMM) with 17,360 hectares oil palm plantation in Belitung Island in Bangka Belitung; PT Kayung Agro Lestari (KAL) with 13,880 hectares oil palm plantation in Ketapang, West Kalimantan, operated by our subsidiary PT Kayung Agro Lestari (KAL); PT Putera Manunggal Perkasa (PMP) with 9,024 hectares have been developed for oil palm plantations, where 81,102 hectares have been set aside for conservation area and the remaining is for infrastructure. Our development plantations are managed in compliance with RSPO and ISPO standards and we will apply for RSPO and ISPO certifications when they begin operating commercially. PT. Kayung Agro Lestari – Kayung Agro Lestari POM is located in Ketapang Regency, Kalimantan Barat Province, Indonesia with certification unit consist of 1 (one) palm oil mill, 4 (four) oil palm estates under company management and 3 (three) cooperative/smallholder plantations.


