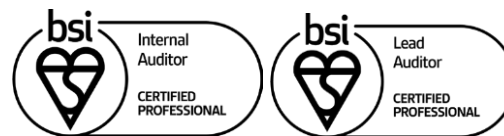

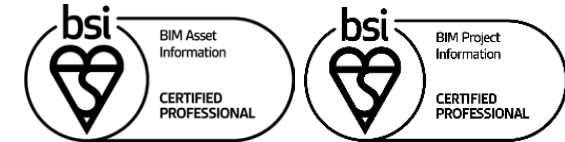

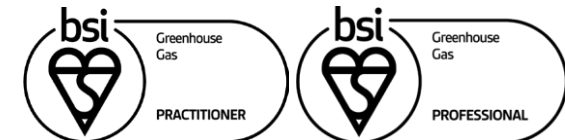
BIM Qualifications
